2. Ghost Hunt Participant hereby agrees to pay APS a fee per participant, made payable to "Alabama Paranormal Society" for a Paranormal Class 101 and Ghost Hunt with APS.
3. Failure of the participant to abide by the obligations of this agreement shall give APS the option to immediately cancel this agreement, providing verbal notice is given to the Ghost Hunt Participant.
4. The participant further agrees to refrain from use of any drugs or alcohol, smoking inside any of the buildings, or involvement in any inappropriate behavior in not keeping with the serious nature of the Ghost Hunt.

(Note: An off duty police officer will be present during the entire Ghost Hunt)

5. The participant acknowledges that they have read, understood, and agree to the rules and regulations found at our website under "Rules".
6. APS makes no warranties with respect to the Ghost Hunts. In no event will APS be liable for direct, indirect, incidental, or consequential damages that are in any way related to the Ghost Hunt.

8. If for ANY reason you cannot attend the date/time of the Ghost Hunt that you have paid for, you will receive credit for another Ghost Hunt. You may also send someone else in your place provided that they meet the age requirement and submit a Registration Form/Liability Waiver. You can notify us anytime of this change up to one day prior to the hunt.
9. I realize that others may be in the building taking photos and my image may be captured. By signing this form, I grant permission to participants, APS, and organizers to post these photos to various paranormal websites.
10. This agreement contains the entire agreement of the parties and there are no promises or written conditions in any other agreement whether oral or written. This agreement supersedes any other prior oral or written agreement between the parties.
